


Technology

- + The world's top 5 Software companies along with 7 of the world's top 10 Technology companies have operations in Ireland

World Class Irish Talent

Half of 25-54 yr olds in Ireland have a third-level qualification - the highest level in Europe

1 in 4 graduates of higher-education came from STEM courses

Significant investment from the Irish Government into quality of technology skills in Irish Education

33 Tech related Courses (Undergraduate & Postgraduate) in Ireland

Multinationals maintain strong links with universities and institutes of technology to develop specific courses and modules to meet a company's specific needs
